Reply to the above said application has been filed by IO. Same is taken on record. Copy of the same supplied to Ld. Counsel for applicant/accused.

Ld. Counsel for applicant/accused submits that applicant/accused is in JC since 21.08.2024 and he has been falsely implicated in the present case. It is further submitted that nothing has been recovered for the possession of the applicant/accused and the recovery shown , the same has been planted upon him more over entire material investigation have already been concluded and chargesheet has been filed. It is further submitted that entire investigation have been conducted only at the instance of information received from secrete informer of the police more over TIP of the applicant/accused was got conducted by IO as per full proofed plan as such the face of applicant/accused has already been shown in PS before being sent him in JC. It is further submitted that there are fourteen witnesses and more over FSL report qua weapon has to come and trial will take a time. It is prayed that above said application may kindly be allowed.

On the other hand, Ld. Additional PP for State strongly

opposed the bail application and submitted that allegations against the applicant/accused are serious in nature. It is prayed that the above said application may kindly be dismissed.

This court has given thoughtful consideration to the submissions made by Ld. counsel for applicant/accused and Ld. Additional PP for State and has also perused the record placed before the same.

Briefly stated, the present FIR bearing no. 610/2024 has been registered at PS Shahbad Dairy U/s. 309(6)/311/317(2)/3(5)/61(2) BNS & U/s. 25/27 Arms Act. There are allegations against applicant/accused **Sunil** and his co-accused person committed robbery for an amount of Rs. 6,13,000/- . As per the reply of IO, victim has correctly identified the applicant/accused **Sunil** during Test Identification Parade. Further, IO has filed previous involvement record of applicant/accused which goes on to show that he is previously involved in various criminal cases and he is a habitual offender. Releasing applicant/accused on bail at this stage may cause threat to the witnesses.

Keeping in view of the above discussion and also considering the severity and the gravity of offence as well as seriousness of allegations, the **present bail application of applicant/accused is hereby dismissed.**
