Yesterday, this court had received a copy of letter from the Computer Branch, Rohini Courts, Delhi, of the Under Secretary Dr. Rajiv Ranjan, Ministry of External Affairs, Govt. of India, vide which it was told to the court that the guarantee letters of the Indian representatives who would go at Switzerland, needed to be sent to the Federal Department of Justice & Police in advance and the Indian representatives who would go at Switzerland had signed the same in this court and this court had sent the same in original to the Ministry of External Affairs through the concerned SHO and this court had also requested to the Ministry of External Affairs to facilitate the Indian representatives in getting VISA and in

response thereof, a letter has been received from Computer Branch, Rohini Court today, of Under Secretary (Extradition), Ministry of External Affairs, vide which the delegation is requested to urgently apply online for political clearance by Ministry of External Affairs on its Web Portal and once, the political clearance is granted, the Visa Note will be issued by CPV Division of Ministry to facilitate for issuance of Visa by the Embassy of Switzerland in New Delhi. This court has apprised to all the persons who would go at Switzerland but the Ld. Counsel for accused has submitted that the fee for applying the VISA is too huge and they will apply after receiving the fee from the Govt of NCT of Delhi. But as the Additional Secretary has apprised to the court that funds have not yet been arranged, so he is requested to arrange the funds expeditiously, so that the date already fixed as 15.02.2018 by the Swiss Authorities for the examination of the prosecution witness Saranjeet Singh in Switzerland may not go in Waste and the Indian representatives may apply for the VISA.

At this stage, Ld. Special PP for the State seeks passing over of the matter till 03.20 PM for moving some applications. So, the matter stands passed over till 03:20 PM.
