AWARD U/s. 21 OF THE LEGAL SERVICES AUTHORITY ACT, 1987

Consequently, **Accused Nos.1 to 4 are acquitted U/s.320(8) Cr.P.C** for the offences punishable **Secs.323, 325 r/w.34 of IPC**.

Award is passed accordingly.

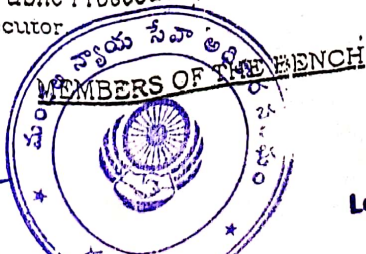
