Order Below Exh.01 in R.C.C. No. 380/2022

(Passed on 16/11/2022)

The officer-in-charge of Sindkhed Raja, Police Station has filed charge-sheet vide section 173(2) of the Code of Criminal Procedure, after completion of the investigation in C.R. No.181/2022. The accused is produced before me by the Jail authorities through video conference in the presence of his learned advocate Shri. G.G. Kankal.

The accused is alleged to have committed offences punishable under sections 302 r/w. section 34 of the Indian Penal Code. The offence punishable under section 302 of the I.P.C. is exclusively triable by the Court of Sessions. The provisions of section 207 of the Code of Criminal Procedure are complied with, by supplying the accused with the copies of the Police Report, documents and statements of witnesses etc. as specified in that section. The accused is already represented by a lawyer of his own choice. He has filed a pursis at Exh.03 stating that he has received the copy of charge-sheet and documents alongwith, that he would remain present before the Hon'ble Sessions Court, Mehkar on the date fixed for appearance and that the accused is being represent by an advocate of his own choice. Thus, the case is fit to be committed for trial to the Court of Hon'ble Additional Sessions Judge, Mehkar, Tq-Mehkar, Dist-Buldhana. Hence, the following order is passed :-

:- ORDER :-

- i) The present case i.e. R.C.C. No.380/2022 is hereby committed to the Court of Hon'ble Additional Sessions Judge, Mehkar, Tq-Mehkar, Dist-Buldhana, vide section 209 of the Criminal Procedure Code.
- ii) The accused is remanded to the Judicial Custody until commitment of the case and also during and until the conclusion of trial before the Hon'ble Court of Sessions, vide section 209 (a) and (b) of the Criminal Procedure Code.
- iii) The accused shall be produced before the Court of Hon'ble Additional Sessions Judge, Mehkar, Tq-Mehkar, Dist-Buldhana on 28/11/2022 by the Jail authorities.
- iv) The record of the case and the documents and the articles, if any, which are to be produced in the evidence be forthwith sent to the Court of Hon'ble Additional Sessions Judge, Mehkar, Tq-Mehkar, Dist-Buldhana.
- v) The Police Station Officer, Sindkhed Raja police station is directed to produce muddemal property, if any, in the Court of Hon'ble Additional Sessions Judge, Mehkar, Tq-Mehkar, Dist-Buldhana on or before 28/11/2022 positively.
- vii) The learned Public Prosecutor be notified of the committal of the case to the Court of Hon'ble Additional Sessions Judge, Mehkar, Tq-Mehkar, Dist-Buldhana.
