Sh. Devender Singh, Ld. Counsel for accused Karamveer.
Accused Karamveer in person.
Accused Ram Chander is stated to be expired.

Perusal of record reveals that NBW's were issued against
accused Karamveer on 05.06.2026.

Application seeking cancellation of NBW has been filed by
accused along with fresh Vakalatnama in favour of Ld. Counsel,
Vakalatnama is taken on record.

At this stage accused submits that presently he has been
staying along with his brother at the below mentioned address:

**“H.No:112, 3rd floor, Green Hills Apartments, Pocket-A,
Rohini, Sector-23, New Delhi.”**

The address as given by the accused may be reflected in the
present case. Manager (Legal) of complainant company seeks time to file
amended memo of parties, same may be filed within one week from
today.

On the ground mentioned in the application, operation of
NBW's stands stayed till next date of hearing.

Perusal of record reveals that accused No.1 Sh. Ram

Chander had already died on 24.12.2025, however no death certificate has been filed. Death verification report not filed despite directions. Report has been filed by the IO stating that despite visiting the address of accused the same was found locked and as no body was found on the premises the death verification report could not be filed before the court and seeks sometime for filing the same.

Accused Karamveer has furnished his fresh residential. Accordingly, issue fresh notice to IO/SHO for filing death verification report qua accused Ram Chander, positively by next date of hearing.

Bail application is filed by Ld. Counsel for accused Karamveer.

Submissions heard.

The present case is U/S 135 of the Electricity Act. The case is based upon the documentary evidence. Trial of this case will take its own time. **Considering all these facts, the accused Karamveer is admitted on bail on furnishing the personal bond in the sum of Rs.10,000/- with one surety of the like amount.**

Personal bond furnished and accepted till next date of hearing.

The documents have been supplied to Ld. Counsel for accused Karamveer, who has gone through the same and submitted that same are complete.

At this stage it is submitted by Ld. Counsel for accused that accused is ready and willing to settle the present matter with the complainant company.

At request of accused present matter is referred to National Lok Adalat which is scheduled to be held on 12.09.2026.

In view of the submission made matter be placed before National Lok Adalat which is scheduled to be held on 12.09.2026, in case if no settlement is arrived at, the matter be re-list before this court on 24.09.2026.
