ORDER BELOW EXH.1

[Passed on 18.01.2023]

The present application is filed under the provisions of the Bombay Regulation VIII of 1827 for issuance of the heir-ship certificate.

Brief facts are as under,

2. Deceased **Suresh Punjaji Bhatkar** was husband of applicant No.1 and father of applicant No.2. Deceased **Suresh Punjaji Bhatkar** died on **15/07/2017**. Applicants are only heirs of deceased **Suresh Punjaji Bhatkar**. Applicants, lastly, prayed that the legal heir-ship certificate may kindly be issued in their favour.

3. After receipt of the application, paper proclamation and citation notice were issued. Accordingly, citation notice duly published vide report Exh.06, 07 and 10 respectively.

4. Applicant No.1 has filed her evidence affidavit at Exh.11. She stated on oath that her husband **Suresh Punjaji Bhatkar** died on **15/07/2017**. Applicants are legal heirs of deceased **Suresh Punjaji Bhatkar**. Applicants have filed death certificate of deceased **Suresh Punjaji Bhatkar** at Exh. 12. It appears that deceased **Suresh Punjaji Bhatkar** died on **15/07/2017**. Applicants have field verified copy of their Adhar card at Exh.13 and 14. Applicants have filed copy of News paper “Matrubhumi”, dtd.07.12.2022 at Exh.16. The public notice was published in the said news paper.

5. In spite of publication of citation notice and Paper publication, nobody has taken objection to the present application. Therefore, on the basis of oral evidence of applicants No.1, it reveals that applicants are only legal heirs of deceased **Suresh Punjaji Bhatkar**. Applicants need legal heirship certificate for the purpose of mutation of their name to 7/12 extract of Gat No.13 situated at Mauja Ambada, Tq.Achalpur. Applicants have filed 7/12 extract of Gat No.13 at Exh.15. It appears that the name of deceased **Suresh Punjaji Bhatkar** is mutated to it as joint owner along with other co-sharer.

6. Considering the above said discussion, the application deserves to be allowed. In the result, I proceed to pass following order:-

ORDER

- (1) The application is allowed.
- (2) Issue heirship certificate in the name of applicants recognizing them as legal heirs of deceased **Suresh Punjaji Bhatkar**.
- (3) The application is disposed of accordingly.
