ORDER

This order of mine shall dispose of two anticipatory bail applications under Section 482 BNSS, one filed by applicant Bobby Singh and another filed by applicant Balkar Singh, in FIR No.47 dated 28.07.2025, under Sections 118(1), 115(2), 351(2), 193(3), 190 P.S. Dharamgarh, for grant of bail.

2. Ld.counsel for applicant Bobby Singh has submitted that applicant has been falsely implicated. His name does not figure in the statement of the complainant though he is now being alleged to be implicated as Mana Singh @ Fauji son of Kaur Singh. He has prayed for the acceptance of bail application.

3. Ld. Counsel for applicant Balkar Singh has submitted that Balkar Singh has also been falsely implicated. No offence is made out against him. Co-accused have already been released on regular bail. He has prayed for the acceptance of bail application.

4. On the other hand, Ld. Addl. Public Prosecutor for the State assisted by ASI Sukhchain Singh and Sh.J.S.Sidhu, Advocate for complainant has opposed the bail application alleging that all the accused in prosecution of common object of their unlawful assembly had inflicted simple as well as grievous injuries on the person of Satnam Singh. Applicant Bobby Singh is also known by the name of

Mana Singh @ Fauji and has been nominated in the statement of injured. They do not deserve the concession of anticipatory and have prayed for dismissal of both bail applications. Police record has been produced, which is seen and returned.

5. I have considered the submissions advanced by both sides and have perused the record.

6. Perusal of record shows that instant case was registered on the statement of complainant Amandeep Singh on the allegations that on 27.07.2025, at about 7:30 pm, he along with his friend Satnam Singh, Karamtej Singh, Bhupinder Singh had gone to their fields and after finishing their work, they sat in the room in their fields; that 5-6 motorcycles with 11-12 persons came from the side of fields of Hardev Singh who exhorted that he should be taught a lesson as to how he could sow Paddy. Jagtar Singh was armed with Sword, who gave blow of the same which fell on his left leg. Sukhvir Singh and Sikander Singh threw him on the ground and caught hold of him from his arms. Jagraj Singh gave a sword blow towards his right bicep. Hardev Singh gave iron rod blow on the backside of his neck. Mana Singh and Lakha Singh caught hold of Satnam Singh and put him down and told that they should be killed. In the meanwhile, Gill Boxer gave sword blow on the left leg of Satnam Singh. Jama gave a blow with sword on the right leg of Satnam Singh. Kuldeep Singh gave blow with iron Garari on left arm of Satnam Singh and Hardev Singh gave blow with iron Garari on the backside i.e. left shoulder of Satnam Singh. Sukhvir

Singh gave Garari blow on the back of Satnam Singh. Gill Boxer gave Garari blows on the chest of Satnam Singh and on the right arm. Gill Boxer snatched mobile phone of Satnam Singh and said persons fled with their weapons. Motive of the occurrence was that they had dispute of land with Gurmail Singh of their village and said person had been called by Gurmail Singh and Hardev Singh to take possession of the land.

7. MLR of injured Amandeep Singh reveals three injuries, out of which injury nos.1 and 2 were declared to be simple and injury no.3 was declared to be grievous.

8. MLR of injured Satnam Singh reflects 07 injuries and all the injuries were found to be simple.

9. As per version of Investigating Officer, Mana @ Fauji involved in the commission of offence is also known by the name of Bobby Singh son of Darshan Singh who had been nominated as Mana @ Fauji son of Kaur Singh. As per the version of prosecution, Mana Singh is alleged to have caught hold of Satnam Singh alongwith Lakha Singh and thereafter, the other accused had inflicted injuries. Balkar Singh @ Jama had caused blow with sword on the right leg of Satnam Singh. So, taking into consideration the kinds of weapons used in the commission of offence and one injury having been caused on the backside of head of Amandeep Singh with rod attributed to Hardev Singh which could have proved fatal, I do not find any sufficient ground to grant anticipatory bail to both the applicants. Therefore, both
