Personal bond has been furnished and the same is hereby accepted till the next date of hearing.

Ld. LAC seeks some time to furnish the bail bond.

The documents have been supplied to Ld. LAC. Ld. LAC has gone through the documents. Same are complete.

Summons with respect to the accused Pallu has been issued, but not received back. Let fresh summons be issued to the accused Pallu for the next date of hearing to be executed through IO concerned.
