The accused person be set at liberty. However, the sureties shall stand discharged after the lapse of a period of six (06) months as per the provision of section 437-A of Cr.P.C.

However, it must be noted that the victim shall have the right to prefer an appeal as enshrined under proviso to Section 372 of Cr.P.C and, if necessary, avail free legal aid and assistance from the legal services authorities concerned to prefer and prosecute such appeal.
