None for complainant.

O R D E R:-

Applicant/accused has filed this pre-arrest bail application on the allegations that she is innocent and has been falsely implicated in the present case. In fact, name of applicant/accused does not figure in the complaint case and the summons which have been received by the

applicant are in the name of Balwinder Kaur wife of Lovely. The complainant has very cleverly changed the identity of the applicant/accused as per his wish by mentioning Gurpreet Kaur @ Balwinder Kaur wife of Charanjit Singh @ Lovely. Applicant/accused has been summoned to face trial in criminal complaint for commission of offence punishable under sections 342, 452, 506, 34. All the other offences are bailable except one under section 4523 IPC. Her custodial interrogation is not required in the complaint case as nothing is to be recovered from her. Hence, the present application.

2. Notice of bail application was issued to complainant, but none appeared on behalf of complainant/respondent. Record has been requisitioned.

3. I have heard arguments of counsel for the applicant/accused and have gone through the record.

4. Applicant/accused has been summoned to face trial for commission of offence punishable under sections 342, 452, 506, 34 of IPC passed by learned Judicial Magistrate Ist Class, Ferozepur. Custodial interrogation of the applicant/accused is not required in the complaint case and she has been summoned just to procure her presence before the learned trial court for trial. Even her name does not

figure in the complaint. As such, applicant/accused is directed to appear before the learned trial court and the trial court shall release her on interim bail subject to its satisfaction. The applicant shall also abide by the conditions as specified under section 438(2) of Cr.P.C. Lower court record be returned and bail application is adjourned to 27.10.2023 for further proceedings.
