1. File has been taken up today on three (03) applications i.e.
(1) for cancellation of NBWs and issuance of Production
Warrants of accused **Gopal Kumar Soni** moved on behalf
of the applicant/accused (2) for release of document i.e.
Registration Certificate of vehicle No. DL-3S-FC-3438
filed on moved on behalf of Mr. Abdulla, applicant/surety
of the accused Gopal Kumar Soni and (3) release of
document i.e. Registration Certificate of vehicle No.
DL-3S-FJ-6184 moved on behalf of Mr. Abdulla,
applicant/surety of the accused Gopal Kumar Soni, all
dated 18.08.2025.
2. It is submitted by the counsel for accused Gopal Kumar
Soni that he has been arrested in FIR No. 299/2025, PS

Sunlight Colony on 27.07.2025 and, therefore, his surety in the present matter wants to withdraw.

3. Heard. Perused. Considered.
4. On perusal of record, it transpires that vide order dated 23.07.2025 NBWs were issued against the accused Gopal Kumar Soni with Notice under Section 446 Cr. PC to his surety and the same have not been executed.
5. No cogent reason has been disclosed on behalf of accused Gopal Kumar Soni regarding his non-appearance on 23.07.2025 *(he was arrested in other case on 27.07.2025)*.
6. **In the circumstances, there is no ground for cancellation of NBWs against the accused Gopal Kumar Soni and his application in respect of cancellation of NBWs is hereby dismissed.**
7. **Accused Gopal Kumar Soni be taken in the custody in the present matter.**
8. As regards the second part of his application for issuance of production warrants, the same is impliedely allowed vide order dated 19.08.2025 when his production warrants had been issued.
9. **The application filed on behalf of accused Gopal Kumar Soni for cancellation of NBWs and for issuance for production warrants is accordingly disposed of.**
10. As regards the two applications filed by Mr. Abdulla, surety of accused Gopal Kumar Soni, as accused Gopal

Kumar Soni has been taken into custody, Mr. Abdulla is discharged from being his surety, his documents be released to him.

11. It is informed by the JA / Reader of the Court that only the **Registration Certificate of Vehicle No. DL-3S-FC-3438** in the name of Mr. Abdulla has been retained on record and no other document was retained.

12. **In the circumstances the above stated Registration Certificate be released to the applicant Mr. Abdulla.**

13. **Both the above stated applications filed by Mr. Abdulla, surety of accused Gopal Kuamr Soni are accordingly allowed.**

14. **Matter be listed on the date already fixed i.e. 03.09.2025.**
