The concerned bank is directed to not issue any cheque book and debit card to the claimant (s) and if the same have already been issued, the bank is directed to cancel the same and make an endorsement to that effect that on the passbook of the claimant. Claimant (s) are directed to place on record two photographs and their attested specimen signatures from the bank, a copy of the bank pass book with such endorsement from bank, with their Aadhar Card (s) and PAN Card (s) on the next date of hearing. The claimant (s) shall also furnish complete postal address of the bank with their IFS Code and MICR number before the court on the next date of hearing. A copy of this order be given dasti to the claimant (s) for being

shown to the bank for compliance.

5. Further, in view of Rule 32(2) of amended rule of 150A of MV (5th amendment) Rules effective from 01.04.2022 r/w Annexure XIII, **Procedure For Investigation of Motor Vehicle Accidents**, claimants are directed to place on record the following documents, if not already filed:

(a) Aadhaar Card and PAN Card;

(b) Details of the Aadhaar Linked Bank Account(s) of the Claimant(s) near the place of their residence along with the proper endorsement; and

(c) Two sets of photographs and specimen signatures of the claimant(s).

The next date of hearing be mentioned on the Disability Certificate.

In case it is found that the claimant is suffering from any disability, in that event three attested copies of the Disability Certificate be also sent along with the Disability Certificate.
