Subsequent to recovery of the said liquors from the shop of Khokan Ch. Saha, S.I Sanjib Debbarma seized those liquors by preparing a seizure list. This is my signature on the said seizure list prepared (**on identification marked as Exbt.P-1/Pw-1**).

CROSS-EXAMINATION :-

No separate command was issued in my name while accompanied S.I Sanjib Debbarma to Bankar Market.

It is a fact that we went to Bankar Market after sun set.

Bankar Market is surrounded by many a shops with many a persons manning those shops.

It is a fact that gala seal impression was not put on the packets wherein the seized liquors were put in following the seizure of the same.

It is not a fact that on 03.09.22 I did not accompany S.I Sanjib Debbarma to Bankar Market and therein I including others did not search the shop of Khokan Ch. Saha.

It is not a fact that today I am deposing falsely at the behest of my superior officer.

Subsequently the liquors recovered were seized by S.I Sanjib Debbarma bring the same to the P.S. A seizure list was prepared by S.I Sanjib Debbarma in respect of seizure of the liquor recovered wherein in put my signature as one of the seizure witnesses. This is my signature on the said seizure list prepared (**on identification marked as Exbt.P-1(A)/Pw-2).**

CROSS-EXAMINATION :-

Following the recovery of liquors, The seized liquors were kept at Police Mal Khana.

It is a fact that number of seized liquors in connection with different c cases are still there at Police Mal Khana.
