Today is fixed for further hearing and order and awaiting report from DLSA regarding mediation between the parties.

Both the parties are present along with their respective Ld. Advocates.

One petition is filed on behalf of the petitioner father for celebrating birthday of minor child Shrinika Roy on 20.09.2025 by the father petitioner as well as his family members and also for custody of the minor child during ensuing Puja celebration and festivals with the child and family members.

So far as birthday celebrating of the minor child is concerned on 20.09.2025, in presence of both the sides and their Ld. Counsels, birthday celebration of child by the father and mother of the child is hereby allowed to the effect that birthday celebration will be performed in **South City Mall(Time Zone and Food Zone) on 20.09.2025 time from 12 noon to 2:00 P.M.** in presence of both the sides and in presence of one of the Ld. Advocate of both the sides but in presence of two police personnel of Jadavpur P.S. so that the birthday celebration of the child by the father and grandmother can be performed smoothly without any untoward incident keeping in view of the welfare of the child.

So far as custody of the child during ensuing Puja celebration and festivals with the child and family members is concerned, the same shall be adjudicated on 25.09.2025 after taking into consideration W.O. to be filed by and on behalf of the mother.

At the time of birthday celebration of the child by the father and grandmother, mother is hereby directed to maintain a distance from birthday celebration spot but within her eye sight so that birthday celebration of the child by the father and the grandmother can be performed smoothly without any disturbance.

Parties are directed to maintain the time strictly scheduled time for birthday celebration as mentioned above.

To **25.09.2025** for consideration of temporary custody of the child as prayed by the father during ensuing Puja vacation. W.O., if any, in the meantime.
