This is a transfer application under Section 448 BNSS, 2023 (earlier Section 408 Cr. P. C.) moved on behalf of the applicant for transfer of case i.e. SC No.798/2022 FIR No.449/2020 PS Amar Colony, titled as State vs. Jagjeet Singh & Ors., pending in the Court of Mr. Honey, Id. ASJ-04 (Spl. Judge NDPS), South East District, Saket Courts, New Delhi to the Court of Ms. Geetanjali, Id. ASJ (FTC)-03, South East District, Saket Courts, New Delhi, where another connected case i.e. SC No.92/2021 FIR No.453/2020 PS Amar Colony titled as State vs. Vinay Kumar & Ors. is pending.

It is submitted by the Id. Counsel for the petitioner that there are two cross FIRs, pertaining to same incident and involving substantially the same set of parties i.e. FIR No.449/2020 & FIR No.453/2020, which are pending before two different Courts. He further submitted that earlier both the FIRs i.e. SC cases were being tried by one Court i.e. the Court of Id.

ASJ-04 (Spl. Judge NDPS), South East District, Saket Courts, New Delhi. However, on account of administrative reasons/orders, the case i.e. SC No.92/2021 FIR No.453/2020 titled as State vs. Vinay Kumar & Ors. was transferred to the Court of Ms. Geetanjali, Id. ASJ(FTC)-03, South East District, Saket Courts, New Delhi. Id. Counsel for the petitioner prayed that since both the cases arise out of cross FIRs between the same set of parties and in order to avoid conflicting judgments as well as in order to save the valuable judicial time, the case i.e. SC No.798/2022 FIR No.449/2020 titled as State vs. Jagjeet Singh & Ors. pending in the Court of Mr. Honey, Id. ASJ-04 (Spl. Judge NDPS), South East District, Saket Courts, New Delhi is transferred to the Court of Ms. Geetanjali, Id. ASJ(FTC)-03, South East District, Saket Courts, New Delhi.

Id. Counsel for the respondent submitted that he does not wish to file any reply to the transfer petition and moreover, the respondents have no objection if the present application is allowed and both the cases are being tried by one Court.

I have heard the Id. Counsel for the parties and have gone through the record.

In view of the submissions made and the facts and circumstances of the case as well as the fact that both the cases arise out of cross FIRs, which pertains to same incident, it would be appropriate if both the cases are tried by one Court.

Accordingly, the present transfer application is allowed and I order that the case i.e. *SC No.798/2022 FIR No.449/2020 PS Amar Colony titled as State vs. Jagjeet Singh & Ors. is withdrawn from the Court of Mr. Honey, Id. ASJ-04 (Spl. Judge NDPS), South East District, Saket Courts, New Delhi and is transferred to the Court of Ms. Geetanjali, Id. ASJ (FTC)-03, South East District, Saket Courts, New Delhi for proceeding further in accordance with law.*
