Shakeela & ors. vs. Javed Ali & ors.

Fresh petition received by way of assignment. It be checked and registered.

Present: Sh. Wasim Waqar, Ld. counsel for petitioner.

This is a fresh claim petition filed u/s 166/140 MV Act by LRs of deceased who suffered injuries in an accident which took place on 03.02.2025 in front of ABES, Sector 9, Ghaziabad, U.P. i.e. outside the territorial jurisdiction of this tribunal after amendment of 01.04.2022.

The offending vehicle was driven by R1, owned by R-2 and insured with R-3. R-4 is Nodal officer of R-3. Office of Insurance company is within the territorial jurisdiction of this Court.

Petitioner is directed to **file certified copy of DAR**, if made available to him and to take **necessary steps for its transfer** to the same jurisdiction where he/she intends to pursue the claim. **Petitioner is directed to file certified copy of charge sheet/complete criminal record by next date.**

As the accident has taken place in front of ABES, Sector 9, Ghaziabad, U.P., i.e. outside the territorial jurisdiction of this Tribunal, in order to ensure that no simultaneous claim proceedings are being pursued by the same claimant before the other Tribunal, let a **copy of this order be sent to concerned Learned MACT court as an intimation of pendency of a claim petition** by the claimant before this court.

In view of practice directions issued vide circular no.134/Rules/DHC dated 14.05.2025 pursuant to the decisions of Hon'ble Supreme Court in Re "*Compensation amounts deposited with Motor Accident Claims Tribunals and Labour Courts*" (Writ Petition(C) No.7 of 2024), petitioner(s) are directed to:

- a) Furnish their Aadhar, PAN details, e-mail id, if any, if not already filed;
- b) File their bank account details alongwith either a certificate of the banker giving all details of the bank account of the petitioner(s) including IFS code, or a copy of cancelled cheque of the bank account. These documents, if not already filed, be produced and filed within one month;
- c) Update information regarding the bank accounts, e-mail id, in case of any change therein.

In addition to the above, petitioner(s) are also directed to file two sets of photographs and their specimen signatures as per Rule 32(2) of Amended Rule 150A MV (5th amendment) Rules.

In terms of directions passed in Re "*Compensation amounts deposited with Motor Accident Claims Tribunals and Labour Courts*", **notice be issued to all the respondents SUBJECT TO FILING OF** the above details and upon filing of PF/RC/speed post, returnable on **23.02.2026**. Dasti be also given.
