This petition coming for settlement on this day, the Tribunal passed the following:-

AWARD

This is an application U/s.166(1) of the M V Act, 1988.

The claim has been settled between the petitioner and the third respondent for an amount of **₹.40000/- (Rupees Forty Thousand only)** and a separate joint memo has been filed. In view of the settlement an award is to be passed as follows:-

In the result:-

- a) Compensation of **₹.40000/- (Rupees Forty Thousand only)** is awarded in favour of the petitioner;

- b) The 3rd respondent shall pay the said amount to the bank account **MACT, Thrissur with State Bank of India, Civil Station Branch, Ayyanthole, Thrissur bearing No.00000042806741408 with IFS Code SBIN0070164;**
- c) The 3rd respondent shall report transfer of the amount to the account of the MACT, Thrissur in the prescribed format as mentioned in Circular No.1/2024 dated 06.03.2024 of the Hon'ble High Court of Kerala;
- d) On receiving intimation regarding deposit of the amount and confirming the same, the Office of this Tribunal shall take steps for fund transfer of the amount to the petitioner's bank account;
- e) The petitioner has not produced the bank account details and accordingly the amount continue in deposit with the account of MACT, Thrissur and that share can be released through the bank account of the petitioner on furnishing the bank account details within one month. In default of furnishing the bank account details that share will be deposited as a fixed deposit for a period of 2 years with the State Bank of India, Ayyanthole branch referred to earlier;
