

**ORDER BELOW APPLICATION FOR RESTORATION OF SESSIONS
CASE No.11/2013.**

- 1] An application has been made by Ld. Additional District Judge at Gondal submitting that, Sessions Case No.11/2013 has been shown as disposed off in CIS system. However, looking to the order passed by the then 8th Additional District & Sessions Judge at Gondal, the accused was directed to be detained in safe custody under the provisions of Sec.330(2) of Cr.P.C. read with Sec.24 of Indian Lunacy Act,1912 in the hospital for Mental Health, Delhi Gage, Shahibag Road, Ahmedabad. While, passing an order below Exh.22, the operating portion of the said order is re-produced herein below :-

The Accused Shispal Naranbhai Ahir, age 25 Yrs. Resident at Shapar Veraval, Ta.Kotda Sangani at – present Sub Jail Gondal is hereby ordered to be detained in safe custody, under the provisions of Sec.330(2) of Cr.P.C. r/w. Section 24 of Indian Lunacy Act,1912, in Hospital for Mental Health, Delhi Gage, Shahibag Road, Ahmedabad.

- 2] It is requested by Ld. Additional District Judge at Gondal that, the matter has not been disposed off finally, however, the same has been shown in CIS as disposed off. The physical file is still pending in the said court, and therefore, requested this office to restore the said matter in CIS and to dispose off the same.
- 3] It is true that 8th Additional District & Sessions Judge at Gondal had passed an order on 08/05/2018, however, due to some inadvertent mistake of registry or employee working in the office of the then 8th



Additional District & Sessions Judge at Gondal, the matter was shown as disposed off in CIS system, and therefore, it would be in the interest of justice if the matter be restored in CIS system for the reason that physical file is still lying with the court of Additional District Judge at Gondal and the same is still pending dispose for disposal.

- 4] In view of the aforesaid, Registry Gondal is directed to restore the matter being Sessions Case No.11/2013 in CIS system.
- 5] This order be uploaded and the Sessions Case No.11/2013 be revived in CIS system.
