File has been taken up today on an **application** filed on behalf of accused Shyed Zamin Ali Nizami seeking recall of production warrants issued vide order dated 01.09.2026 and intimation thereof to the concerned Jail Superintendent.

Heard.

It has been submitted that the applicant/accused Syed Zamin Ali Nizami is on bail in the present matter, however, in between, as he was arrested in some other case bearing FIR No. 170/2026, PS-Hazrat Nizamuddin and was in JC in the said case, he could not appear before this Court on the last date of hearing i.e. 01.09.2026 and accordingly the production warrants were issued for his production on 15.10.2026 in the present case before this court. It is submitted that accused Syed Zamin Ali Nizami has already been admitted on bail in the above-said case FIR No. 170/2026, PS- Hazrat Nizamuddin vide order dated 05.09.2026 of Sh. Ankit Singla, Ld. ASJ (SFTC)/South-East, Saket Courts, New Delhi, copy of which has been placed on record.

Submissions considered and record perused.

Two separate letters dated 05.09.2026 and 06.09.2026 have also been received from the Dy. Superintendent, Central jail No. 8 / 9, Tihar, New Delhi requesting to provide the status of bail of the accused Syed Zamin Ali Nizami S/o Mr. Makhdoon, which have been perused.

In view of the submissions and the record, it is clarified that the said accused Syed Zamin Ali Nizami is on bail in the present case FIR No.185/2023, PS-Hazrat Nizamuddin. Accordingly, the present application is **disposed of** with the directions that the Production Warrants issued by this court vide order dated 01.09.2026 for the production of the said accused Syed Zamin Ali Nizami before this court in the present case FIR No.185/2023, PS-Hazrat Nizamuddin, are **recalled/cancelled**.

Ld. Counsel for the applicant/accused has assured that the applicant/accused Syed Zamin Ali Nizami will appear physically before this court on the NDOH i.e. 15.10.2026 in the present matter, without fail.

Copy of this order be given dasti to the Ld. Counsel for the applicant/accused.

Copy of this order be also sent to the concerned Jail Superintendent for information, record and compliance (if any).
