ORDER

1. Present bail application has been put up before me being Duty Officer moved on behalf of accused-applicant under section 439 of Criminal Procedure Code in FIR No. 147 dated 21.07.2015, P. S. Sadar, Jalandhar, under section 61 of the Punjab Excise Act.
2. Notice of the bail application was issued to the prosecution and Smt. Zeba Khalid, Addl. PP for the State has appeared on behalf of State.
3. Heard. Perusal of file reveals that the accused-applicant was absented from the trial court on 08.04.2019 and ultimately he was declared Proclaimed Offender vide order dated 09.12.2019. Thereafter, he was re-arrested in this case and produced before learned trial court on 04.08.2020 and since then he is in custody. The offence involved in this case is bailable

one. The conclusion of trial shall take considerable long time. No useful purpose shall be served by keeping the accused-applicant behind the bar for unlimited period. As such, learned trial court/Duty Magistrate is directed to release the accused-applicant on bail on his furnishing bail bonds for the sum of ₹50,000/- with one surety in the like amount with the following conditions:

1. That the accused/applicant shall not tamper with the prosecution evidence.
2. That the accused/applicant shall appear before the Court on each and every date of hearing.
3. That the accused/applicant shall not leave country without prior permission of court.
4. File be sent back to learned trial court along with copy of this order and file of this bail application be consigned to record room, Jalandhar.
