Order:-

This order shall dispose of bail application moved on behalf accused/applicant Deepak @ Kalu in FIR No. 137 dated 21.12.2024, U/s. 115 (2), 118 (1), 324 (4), 191 (3), 190 of BNS, P.S. Shri Hargobindpur. It has been submitted in the application that the applicant/accused is innocent person and has not committed any offence as mentioned. It has been further submitted that nothing was recovered from the applicant/accused. Applicant/accused is no longer required for the purpose of investigation. It has been further submitted that the presentation of challan and conclusion of trial will take long time. As such, it has been prayed that the applicant/accused be released on bail.

2. The Ld. APP for the State has not filed any written reply to the present bail application. The Ld. counsel for the applicant/accused as well as the Ld. APP for the State has been heard. Case file has been perused.

3. Heard. It has transpired from the remand papers as well as FIR that there are allegations against the accused that the accused along with his co-accused persons had assaulted the complainant using weapons including Gandasi and Dattar. The specific injury caused with baseball has been attributed to the accused/applicant in the FIR. Further, it has transpired from the remand papers that the accused is in custody since 06.11.2025. After hearing the Ld. Counsel for the accused as well as Ld. APP for the State and going through the case file, this Court is of the view

that the allegations levelled against the accused are yet to be proved and same are matter of trial. Presentation of challan as well as conclusion of trial may take ample time. The accused is not required for further investigation. Nothing remains to be recovered from the accused in the present case. As such, no useful purpose would be served by keeping the accused/applicant in the custody. Hence, in view of the above discussion, the present bail application stands allowed and the accused/applicant Deepak @ Kalu is hereby ordered to be released on bail subject to furnishing their bail bonds/surety bonds in the sum of Rs. 30,000/- with one surety in the like amount, subject to following conditions:-

- i). The accused shall attend the Court on every date of hearing and shall comply with the further conditions of the bonds executed.
 - ii). The accused shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts of the Court or to any police officer.
 - iii). The accused will not leave the country without prior permission of the Court and shall bound to intimate the Court as and when he changes his given address.
4. Bail bonds/surety bonds not furnished. Ahlmad is directed to tag the papers with the main case file.
