Today, the matter is fixed for arguments on charge and seeking report from jail superintendent in respect to order dated 20.12.2024 regarding medical examination of accused Sourav @ Koki.

No report has been received from Superintendent, Tihar Jail.

Ld. Addl. PP for the State submits that he needs assistance of IO to advance arguments on the point of charge.

IO be summoned to appear in person, through DCP concerned for next date of hearing.

At this stage, there is lot of commotion and noises outside the court room and the police official who is making accused Sunny @ Lalu appeared before the court submits that there is crowd of around 25-30 people who have come to meet accused Sunny @ Lalu and have been creating difficulty in the production of said accused by trying to hold his hands.

Submissions heard.

In view of the submissions made, for security purposes, it is hereby directed that accused Sunny @ Lalu, be produced only through video conferencing till further orders in the present matter.

Copy of this be sent to Jail Superintendent concerned for information and compliance.

At this stage, Accused Sourav @ Koki submits that despite directions of the Court on the last date of hearing, he was not taken for medical examination to DDU Hospital and he further submits that no steps have been taken by the jail authorities to give him any medical treatment.

Ld. LAC for accused Sourav @ Koki is not available and matter is kept for 2 pm today.

Accused Sunny @ Lalu be produced only through Video Conferencing in the present till further orders. Intimation in this regard be sent to Superintendent, Tihar Jail for compliance. Copy of the present order be annexed with the Court Notice to the Superintendent.
