offence punishable under Sections 341, 307, 427 of the Indian Penal Code, 1860 (**here-in-after, the Code, 1860**) and **Section 27/54/59 of Arms Act.**

2. Investigation was set into motion on the basis of complaint given by complainant Manish to the police on 06.12.2021 to the effect that he had to appear as witness in a murder case in Sonipat court and when after deposing in the Court, he was coming to Jatwara, Sonipat in his I-20 car No. HR69D/2949 white colour, then at about 05:30 p.m. he reached in front of the house of Hawa Singh, who was his grand father in family relation, near Jatwara Chungi, Purkhas Road, Jatwara, meanwhile a car I-20 No.HR42G/5794 white colour came from the side of village Jahri and parked his car in front of his car. Two boys namely Subham and Sukha came out. Subham broke window pane of his car by brick and Sukha fired upon him with intention to kill him, but he escaped. With these allegations action was prayed to be taken against accused.

3. On this, formal FIR was registered and investigation was conducted. Statements of witnesses were recorded. Accused was arrested.

After completion of investigation, challan against accused was filed under Sections 341, 307, 427, 34 of the Code, 1860 and 27/54/59 of Arms Act.

4. Complete copy of challan given to accused free of cost as envisaged under section 208 Cr.P.C.

After hearing learned APP for the State, learned defence counsel and after going through the material placed on record, this court has come to the conclusion, that there is ample material on the record for further proceeding against accused for commission of alleged offences punishable under Sections 341, 307, 427, 34 of the Code, 1860 and 27/54/59 of Arms Act. Since, the offence punishable under **307** of the Code, 1860 is exclusively triable by the Court of Sessions, therefore, this case is committed to the Court of Learned Sessions Judge, Sonapat for **15.11.2022**. Accused in custody is directed to produce before the court of learned Sessions Judge, Sonapat on that date. Learned Public Prosecutor stands intimated through learned APP present in the court. Reader of the court is directed to prepare Calendra and Ahlmad is
