**Subject to condition that compliance of Rule 8 (2) (b) of Delhi MACT Rules, 2008 be made i.e. with PF evidence by way of affidavit of petitioner and list of witness be filed, issue notice of the claim petition to all the respondents on filing of PF through all permissible modes. Along with notice list of witness and copy of claim petition be annexed.**

Let the certified copy of charge-sheet be filed by the petitioner on or before NDOH.

The petitioner/claimant is directed to open saving bank account in any nationalized bank near the place of his/her residence if already not opened.

The concerned Bank Manager of the Bank, where the petitioner already has a bank account or a new bank account is opened, is directed as follows:

(i). No Cheque Book and ATM/Debit Card be issued to the petitioner without permission of the Court/MACT Tribunal. However, in case the

ATM/Debit Card and/or Cheque Book have already been issued, bank shall cancel the same before the disbursement of the amount.

(ii). The Bank shall not permit any joint name(s) to be added in the savings bank account or fixed deposit accounts of the petitioner. However, money may be released by means of a withdrawal slip.

(iii) The Bank Manager of petitioner's bank is also directed to make endorsement regarding compliance of aforesaid directions on the passbook.

After the Bank Manager makes the endorsement regarding compliance of the aforesaid directions on the passbook of the petitioner, the petitioner shall produce the original passbook having the said endorsements as well as Aadhaar Card and PAN Card before the Tribunal on the next date of hearing or in any case before hearing the final arguments.

If the petitioner fails to comply with the said direction, the disbursement of the award amount (if the award is passed) shall be made subject to the following conditions:

The petitioner shall have to open a MACT compliance Bank account in the UCO Bank, Karkardooma, subject to aforesaid terms and conditions and the petitioner shall also furnish the details of the branch of UCO bank near the place of petitioner's residence to which the bank account of the petitioner in the UCO bank, Karkardooma branch may be transferred subject to all hereinabove conditions.
