COMPLAINCE ASHWANI Vs. NIKKA RAM AND ORS

Ld. Counsel for R3/insurance company submits that the award amount of Rs.11,81,663/- has been deposited vide UTR No. *HSBCR 2202 6021 03482 4249* dated 12.02.2026 in the Bank account of the Tribunal i.e. UCO Bank, Karkardooma, Delhi.

The petitioner has produced his bank details of two bank accounts, one with SBI Nand Nagri, which is the bank near the place of his residence and another is the UCO Bank, Karkardooma, Delhi.

The Manager, UCO Bank, Karkardooma is directed to immediately release a sum of Rs.2,81,663/- to the petitioner by way of transferring the said amount into his MACT Bank A/c of UCO Bank, Karkardooma, Delhi i.e. A/c no.20780110246054, ISFC: UCBA0002078.

Further, Manager, UCO Bank, Karkardooma is directed that balance award amount of Rs.9 lakhs shall be kept secured with UCO Bank, Karkardooma, Delhi in MACAD (Motor Accident Claims Annuity Deposit) in the form of 60 monthly FDRs of equal amount to be prepared in the name of the petitioner for a period of 1 to 60 months in succession, as per the scheme formulated by Hon'ble Delhi High Court vide order dated 07.12.2018 in FAO No. 8433/2003, titled as **Rajesh Tyagi & Others v. Jaibir Singh & Others**.

However, since the bank account in SBI is not an MACT Saving Bank account, the petitioner is directed to get opened an MACT Saving Bank account in a branch of UCO Bank, near the place of his residence subject to the following conditions:

- No cheque book and ATM/Debit Card be issued to the claimant/petitioner without permission of the Court. However, in case the ATM/Debit Card and/or Cheque Book have already been issued, bank shall cancel the same before the disbursement of the amount. However, money may be released by means of withdrawal slip.
- The Bank shall not permit any joint name(s) to be added in the savings bank account or fixed deposit accounts of the claimant.
- The Bank Manager is also directed to make an endorsement regarding compliance of aforesaid directions on the passbook.

After the petitioner opens an MACT Saving Bank A/c in Branch of UCO Bank, near the place of his residence, the Manager, UCO Bank, Karkardooma shall transfer the Bank A/c of UCO Bank, Karkardooma Branch to the Branch of UCO Bank near the place of residence of the petitioner subject to all hereinabove conditions.

Put up for producing the bank details as directed above on 13.03.2026.
