1. Heard on the bail application filed by bail applicants for grant of anticipatory bail in FIR No.29 dated 30.01.2021, Under Section 406/498-A/34 IPC, Police Station Dera Bassi, SAS Nagar, on the grounds that applicants are father-in-law and mother-in-law of the complainant. It is averred that the present FIR is based on totally false and Wrong facts and has been registered to harass the petitioners and extract money and no personal custody of the petitioners is required in the present case and no recovery is to be effected from the petitioners. The petitioners are innocent persons and have not committed any such offence at all and prayed that the bail application of the petitioners may kindly be accepted.

2. After hearing arguments, it is observed that the bail applicants are father-in-law and mother-in-law of the complainant. However, the guilt and innocence of the accused shall be taken into consideration only after appreciating evidence. So, in these circumstances, without delving into the merits of the instant case. Applicants-accused are directed to join the investigation with the IO/SHO concerned within week and are ordered to be released on interim bail on furnishing their bail/surety bonds in the sum of ₹50,000/- each with one surety of the like amount to the satisfaction of I.O./Arresting Officer within one week from today, subject to the conditions mentioned in Section 438(2) Cr.P.C.

IO is directed to join the accused applicant in investigation by maintaining social distancing and by following all the precautions as prescribed for the prevention of Coronavirus.

Now to come up on 17.02.2021 for compliance report as well as the outcome of investigation.
