The above named accused has been sent by the SHO, Police Station-City Yamuna Nagar, District Yamuna Nagar, to face trial for the commission of offences punishable under Sections 69, 115(2), 351(2) of BNS, 2023.

was registered on the complaint of complainant 'S' (name withheld) to the effect that she is 30 years old. She was in friendship with Aman for the last 8-9 years and they are in love with each other. They wanted to marry with each other, but Aman already married six years ago. Aman told to her that his wife is patient of T.B and she is guest of few days, after that he will marry with her. When she was alone in the house, Aman had come to her house and committed wrong act with her forcefully, when she refused, he gave beatings to her. Aman committed wrong act with her several times at her house. She further alleged that on 10.05.2026, Aman took her in 69 hotel, Jagadhri, promised her to marry and committed wrong act with her without her consent and when she refused Aman gave beatings to her and abused her. Aman took her several times in hotel near Santpura Gurudwara, Yamuna Nagar and committed wrong act with her. On 13.05.2026, Aman called her in Park and threatened her if she did not come, he will show her video to her brother, upon which she came to meet Aman in the Park, where she stated Aman to marry her, but he became angry and started beating her and stated that he will not marry with her. She rescued her life with great difficulty and came to her house and disclosed entire episode to her mother. In the night, Aman again came to her house, gave her beatings, abused her in filthy language and threatened to kill her to death. Her mother and sister-in-law (Bhabhi) rescued her from the clutches of accused Aman. She further alleged that Aman is committing wrong act with her for the last 8-9 years on the pretext of marriage and by blackmailing her for video. She prayed that necessary

action be taken against the accused.

3. On the basis of this complaint, case under Sections 69, 115(2), 351(2) of BNS, 2023 was registered. Investigation was conducted. Place of occurrence was inspected and site plan was prepared. Statements of witnesses were recorded. Sexual medical of victim was got conducted from Civil Hospital, Yamuna Nagar and statement of victim under Section 183 of BNS was got recorded. Accused Aman was joined in investigation and duly arrested in the present case. Accused was got medically examined. On completion of all the other formalities of investigation, challan against accused Aman filed before the Court to face trial.

4. Copy of challan and other documents were supplied to the accused, free of costs, as envisaged under Section 230 of BNS, 2023.

5. Heard. At the present stage, prima facie case has been made out against the accused for the commission of offences punishable under Sections 69, 115(2) and 351(2). Since the offence punishable under Sections 69 of BNS, 2023 is exclusively triable by the learned Court of Sessions, therefore, the present case is committed to the learned Court of Sessions under Section 232 of BNS, 2023 for 07.08.2026. Learned Public Prosecutor of learned Sessions Court stands informed through learned APP of this Court. Calendra of the witnesses be prepared and record of the case be sent to the learned Court of Sessions forthwith.

6. Accused Aman, who is in custody in the present case is remanded to judicial custody and jail authorities are directed to produce the said accused, who is in custody before the Court of learned Sessions
