This is an application moved under Section 483 of BNSS, 2023 seeking interim bail for a period of 45 days moved on behalf of applicant/accused Shah Faisal @ Anas.

1. Medical status report of the applicant/accused received. Perusal of this Medical report reveals that applicant/accused is suffering from hemorrhoids (bleeding per rectum), pulmonary tuberculosis (TB), breathing difficulty, fever on/off, weight loss and severe lower backache with radiculopathy left side and he is under regular treatment in GTB Hospital and is taking all the medications prescribed to him. It is also reported that despite medication, inmate is still having fever on/off, chest pain, caught with expectoration with blood in sputum and breathing difficulty and is also suffering from lower back pain with numbness and weakness in both lower legs and bleeding per rectum.

2. Ld. Counsel for applicant/accused has submitted that family members of the applicant/accused wants to get the applicant/ accused medically examined and treated from City Hospital & Trauma Centre, Main Road Gol Chakka, Near Police Check Post, 626/2, Loni Road, East Gokalpur, Delhi-110094.

3. Submissions heard. Record perused. In view of the submissions and considering the medical report of the applicant/ accused,

concerned Jail Superintendent is directed to produce the applicant/ accused before concerned Doctor, City Hospital & Trauma Centre, Main Road Gol Chakka, Near Police Check Post, 626/2, Loni Road, East Gokalpur, Delhi-110094 for his medical examination on 26.03.2025 at 10:00am. One attendant i.e. one of the family members of the accused Shah Faisal @ Anas shall remain present in the hospital during medical examination of the accused. It is made clear that all the expenses shall be borne by the attendant/ family member of the accused/inmate Shah Faisal @ Anas.

4. A report be called from the concerned hospital regarding diagnosis of applicant/accused, line of treatment and how much time will be required for medical treatment of the applicant/accused Shah Faisal @ Anas in the aforesaid hospital.

5. The SHO concerned to directed to depute the IO concerned to be present at the hospital during the examination of the applicant/accused and also direct the IO concerned to collect the aforesaid report from Hospital and to file the same before the Court on the next date of hearing.

6. Put up arguments on the present application on **27.03.2025**.

7. Medical Examination Reports and medical status report of the applicant/ accused as received from City Hospital & Trauma Centre be put up before the Court on the next date of hearing.
