1. Accused Sameer @ Azhar is absent despite repeated calls since morning. NBW issued against the accused Sameer @ Azhar and notice to his surety received back unexecuted with the report that they could not be traced.
2. It seems that accused Sameer @ Azhar is deliberately not appearing before the Court and he is concealing himself so that process against him could not be executed. Accordingly, issue process U/s 82 Cr.PC/84 BNSS against the accused Sameer @ Azhar as per law through IO for 20.07.2026. Bail bond, surety bond of accused Sameer @ Azhar stands forfeited. Issue warrant of attachment against his surety in the sum of Rs.10,000/-for the next date of hearing.

IO is directed to comply with the Judgment titled as **Sunil Tyagi Vs. Govt. of NCT of Delhi & Tanmay Kumar Vs. State (2021) 281 DLT 533** Hon'ble High Court of Delhi, decided on 28/06/2021.

3. Matter is at the stage of arguments on Charge, however, arguments on Charge could not be concluded yet either for want of accused persons or at the request of the Ld. Counsel for the accused persons.

4. Accused Danish has submitted that his Counsel is not available today, he seeks adjournment to address arguments on Charge.

5. Ld. Counsel for the accused Shah Faisal @ Anas and Aman @ Shahbaj has submitted that he does not wish to address further arguments on Charge on behalf of the accused Shah Faisal @ Anas and Aman @ Shahbaj.

6. Ld. Counsel for accused Mohd. Kasim and Kamran has submitted that accused concede the charges against them.

7. At this stage, Ld. Counsel Mohd. Ajmal has filed fresh vakalatnama on behalf of the accused Danish, be taken on record. He seeks adjournment to address arguments on Charge on behalf of the accused Danish.

8. Submissions heard. Record perused.

9. Put up for further proceedings on **20.07.2026**.
