1. A report dated 18.03.2026 is received from the concerned Jail Superintendent reporting that accused Noor Islam @ Saddam has died on 18.03.2026.
2. Mother of the accused Noor Islam @ Pintu has also stated that Noor Islam @ Pintu has died on 18.03.2026.
3. At this stage, Ld. Addl. PP for the State has submitted that since a report regarding death of accused Noor Islam @ Pintu has already been received on record from the concerned Jail Superintendent and mother of the accused has also confirmed his death, therefore, proceedings against him may be abated.
4. Submissions heard. Record perused. Considering the Death report filed by the concerned Jail Superintendent regarding the death of the accused Noor Islam @ Pintu on 18.03.2026, submissions made by his mother and Ld. Addl. PP for the State, proceedings against accused Noor Islam @ Pintu are abated.

Accordingly, Sh. Adarsh Tiwari, Ld. Amicus Curiae for the accused Noor Islam is also discharged as Amicus Curiae for

accused Noor Islam @ Pintu.

5. At this stage, accused Shakeel @ Habibul has submitted that Ld. Amicus Curiae appearing on his behalf has not appeared today, he has requested for change of the Counsel.

6. Submissions heard. Record perused. Ld. Counsel Sh. Adarsh Tiwari who was Amicus Curiae for the accused Noor Islam @ Pintu (now deceased) and is well acquainted with the facts of the present case is appointed as Ld. Amicus Curiae on behalf of the accused Shakeel @ Habibul.

7. PW SI Vineet Pratap Singh has been examined as PW-6, duly cross-examined on behalf of the accused and discharged.

8. Ld. Addl. PP for the State has submitted that no other witness remains to be examined, therefore, PE may be closed.

9. Submissions heard. Record perused. Considering the submissions of the Ld. Addl. PP for the State, PE stands closed.

10. Put up for Statement of Accused Shakeel @ Habibul on 16.04.2026.
