ORDER BELOW EXH.01

01 By way of present application (Exh.39) the applicants are praying to correct the typographical mistake committed in the Para No. 05 Line No.06 of judgment as regards the amount.

02 It is averrement of the applicants that, this court has decided Succession Case No. 28/2022 on 11-09-2023. He further averred that, non-applicants (Office of the Superintendent of Police) have filed pursis Exh. 30 in the matter and informed that, amount of (Pension, GPF and GIS) Rs.19,27,846/- (Nine Thousand, Twenty Seven Thousand, Eight Hundred Forty Six) of deceased Afroz Khan Ameen Khan Pathan is pending in their office. However, non-applicants while informing/written amount of Pension, GPF and GIS, they correctly mentioned that Rs. 19,27,846/- is pending, but while writing in the word they committed mistake and wrongly write amount of Rs. Nine Lakhs Three Thousand Seven Hundred Forty Six is pending instead of Nineteen Lakhs, Twenty Seven Thousand, Eight Hundred Forty Six. Therefore, accordingly in the judgment amount is mentioned as Rs.Nine Lakhs Three Thousand Seven Hundred Forty Six believing on amount written in the word. Therefore, applicants filed

application Exh.39 requesting mistaken occurred by them be corrected.

03 I have carefully perused the specific para of the judgment i.e. Para No.06 of the discussion of Issue No. 01 & 02. So also I have perused the Exh.30 filed by non-applicants i.e Office of the District Superintendent, Buldana and revealed that officials of the Office of Superintendent of Police, Buldana have correctly mentioned while writing amount of Rs. 19,17,846/-, but while writing in words they committed mistake and they wrongly mentioned amount of Rs. Nine Lakhs Three Thousand Seven Hundred Forty Six instead of Nineteen Lakhs, Twenty Seven Thousand, Eight Hundred Forty Six.

04 Therefore, I find that, there is substance in the contentions of the applicants that, there is typographical mistake occurred due to amount mentioned in handwriting by Officials of the Office of the Superintendent of Police, Buldana which needs to be corrected as Rs. Nineteen Lakhs, Twenty Seven Thousand, Eight Hundred Forty Six instead of Rs. Nine Lakhs Three Thousand Seven Hundred Forty Six.

05 Hence, I conclude that, the application deserves to be allowed. With this, I pass following order.

O R D E R

01. The application is allowed.
02. The Para No. 05 line No. 06 of the original judgment to the extent of amount of Rs. 9,03,746/- (Rs. Nine Lakhs Three Thousand Seven Hundred Forty Six) be corrected as Rs. 19,27,846 (Rs. Nineteen Lakhs, Twenty Seven Thousand, Eight Hundred Forty Six)
03. Office is directed to issue Succession Certificate in the name of applicants after payment of requisite Court fee stamp.
04. Parties to take note.
