



ORDER BELOW EXH. 1

1. Present application is preferred by applicant u/s 13(3) of The Registration of Births and Deaths Act, 1969 for directing Registrar (Death and Birth Registration), Dhorpa/Secretary of Gram Panchayat, Dhorpa, Tq. Nagbhid, Dist. Chandrapur to take entry of her birth and date of birth as 09-09-1974.

2. It is contended by the applicant that, she born on dt.09-09-1974 at home at Dhorpa, Tq. Nagbhid, Dist Chandrapur. Due to ignorance her family could not register her birth with Registrar (Death and Birth Registration), Dhorpa/Secretary of Gram Panchayat, Dhorpa. Now due to lapse of time Registrar (Death and Birth Registration), Dhorpa/Secretary of Gram Panchayat, Dhorpa, show its incapacity to register her birth without the order of court. Now for Governmental purposes, she is in need of birth certificate. Hence, prayed to direct the Registrar (Death and Birth Registration), Dhorpa/Secretary of Gram Panchayat, Dhorpa to register her birth as on dt. 09-09-1974.

3. The applicant placed on record verified photocopy of driving license and verified photocopy of school leaving certificate. Said documents shows the date of birth of applicant as 09-09-1977.

4. The applicant filed affidavit, in which on oath she submitted that her date of birth is 09-09-1974 and she was born at Dhorpa, Tq. Nagbhid.

5. The applicant is major and on oath claimed that she born on dated 09-09-1974. Her contention corroborated with school leaving certificate and driving license.

6. The applicant placed on record certificate of Registrar (Death and Birth Registration), Dhorpa/Secretary of Gram Panchayat, Dhorpa showing that her birth is not registered with him.

7. Section 13(3) of the Registration of Births and Deaths Act, 1969 empowers the Magistrate to order the registration of the birth of any person in case it has not been registered within one year of its occurrence.

8. Considering evidence discussed above it is cleared that applicant born on dt.09-09-1974 at Dhorpa, Tq. Nagbhid and her birth is not registered with concerned authority. Hence, I proceed to pass the following order.

ORDER

- 1) Application is allowed.
- 2) Registrar (Death and Birth Registration), Dhorpa /Secretary of Gram Panchayat, Dhorpa, Tq. Nagbhid, Dist. Chandrapur is directed to register the birth of applicant namely

Manorama Pancham Meshram and date of birth as 09-09-1974
subject to payment of prescribed fee if any and as per rules.
