Resultantly, in such view of the matter, it would be appropriate to finalize the interim anticipatory bail which has been already granted by this Court to accused/applicant vide order dated 27.03.2024 and as such, the interim anticipatory bail already granted to accused/applicant is made absolute. This bail application under Section 438 of Cr.P.C is disposed off accordingly. Bail application file be consigned to the Record Room.
