ORDER

1. Vide this common order, four bail applications under Section 482 B.N.S.S, filed by applicants-accused Sona @ Gopi, Jagseer Singh @ Jasbir Singh, Sunil and Anwar, seeking pre-arrest bail in the aforesaid FIR, are being dealt with.
2. Vide order dated 12.12.2024, applicants-accused were directed to join the investigation.
3. Learned counsel for applicants-accused stated that applicants-accused have joined the investigation in furtherance of the interim order

dated 12.12.2024, passed by this Court.

4. Separate statement of of ASI Jagdish Singh, No.188/TT, Investigating Officer, has been recorded in the Court to the effect that, applicants-accused have joined the investigation in the present case on 31.12.2024, and that they are not required for custodial interrogation.

5. In view of the statement of ASI Jagdish Singh, interim order dated 12.12.2024 is, hereby, made absolute. The applicants-accused shall abide by conditions incorporated in Section 482(2) of the B.N.S.S. Accordingly, bail application stands disposed of. Papers be consigned to record room.
