ORDER:

This order finally disposes off an application for pre-arrest bail under Section 438(i) Cr.PC filed by applicants Hussan Singh and Paramjit Singh in case FIR No.0014 dated 9-2-2019 under Sections 452, 323, 324, 447, 148, 149 IPC , registered at Police Station Makhu.

2. Vide a detailed order dated 22-2-2019, the accused had been directed to join the investigation and report of the Investigating Officer was called for. Today ASI Satnam Singh has appeared in the Court and given a statement that the applicants-accused Hussan Singh and Paramjit Singh have joined the investigation on 26-2-2019 in pursuance of order dated 22-2-2019 and they are no more required for custodial interrogation.

3. Heard. The bail applicants Hussan Singh and Paramjit Singh have joined the investigation in pursuance of the Court order 22-2-2019 and they are no more required for further interrogation as stated by the Investigating Officer. There is nothing in the statement of Investigating Officer to suggest that the bail applicants Hussan Singh and Paramjit Singh have not co-operated in the investigation or is creating any hindrance in the same. Hence, in view of the aforesaid, the bail application stands allowed and the interim order dated 22-2-2019 is confirmed subject to the conditions contained therein File be consigned to the Record Room.
