A W A R D

Under Section:21 of L.S.A Act, 1987 & Amendment Act, 1994

- The Respondent No.2 shall pay to the Petitioner (s) a sum of Rs.1,75,000/- (RU ONE LAKH SEVENTY FIVE THOUSAND ONLY) as Compensation for death/in towards full and final.
- No Interest or costs shall be payable Petitioner (s) except as stated in the award.
- The Petition as against the Respondents No.1 & 2 shall stands dismissed without costs, in view of the settlement between the Petitioner (s) and Respondent No.2.

- (d) Sum of Rs.1,75,000/- is directed to be paid to Petitioners after depositing of Amount by the Respondent No.2.
- (e) The Respondent No.2 shall deposit the compensation amount within one month from the Date of this award failing which interest will be calculated on the amount of compensation awarded at the rate of 9% P.A. from the date of award.
- (f) The Parties are entitled for refund of Court Fee paid if any, Necessary Certificate for Claiming Court Fee in the Prescribed Proforma may be issued to the parties for refund of Court Fee as provided under Section:21 (1) of Legal Services Authorities Act, 1987 (as amended) read with Rule:18 of Telangana State Legal Services Authorities Rules, 2016
