File taken up today on an application seeking custody parole for one day, moved on behalf of applicant/accused Sewa Ram.

1. This is an application moved on behalf of applicant/accused for grant of custody parole to the applicant/accused for the purpose of closing loan account.
2. Ld. Counsel for applicant/accused has submitted that the applicant/accused has a loan account with Muthoot Finance Ltd., Vivek Vihar branch vide account no. 03695/MUL/007526 against gold deposits; that daughter of applicant/accused is paying the interest on the gold loan amount; that applicant/accused wishes to close the said loan account to avoid further interest/liability. Therefore, a prayer for custody parole has been preferred for a day to visit Muthoot Finance, Vivek Vihar branch, Delhi for the purpose of closing the loan account and for handing over the ornaments to his daughter so as to save her from paying the

interest over the same; that applicant/accused is ready and willing to fulfill all the terms and conditions, if any, imposed by this court.

3. Ld. Addl. PP for the State has not opposed the grant of custody parole to the applicant/accused for the aforesaid purpose.
4. Reply along with acknowledgment of running gold loan account has been filed by the present IO/Insp. Ashwani.
5. I have heard submissions on behalf of both sides and perused the material available on record.
6. Pertinently, IO has verified the factum of running loan account of applicant/accused with Muthoot Finance Ltd. vide loan account no. 03695/MUL/007526 against gold deposits and an amount of Rs.8789/- is stated to be due as on today. The same is also verified upon perusal of the acknowledgment issued by Muthoot Finance Ltd.
7. In view of the above as well as no objection given by the State, the present application seeking custody parole is disposed of as allowed. Accordingly, applicant/accused is directed to be taken to Muthoot Finance Branch Vivek Vihar, Delhi tomorrow i.e. 02.07.2024 from 10.00 am to 2.00 pm in custody for the purpose of closing the aforesaid gold loan account. Jail Suptd. concerned is directed to make suitable/requisite arrangements in this regard as per rules.
8. Also, authorized person at Muthoot Finance Ltd., is directed to facilitate the closing of said loan account so that the applicant/accused can be taken back to judicial custody

at the earliest.

A copy of this order be sent to Superintendent Mandoli Jail for information and necessary compliance without fail.

As prayed for, copy of order be also given dasti to Ld. Counsel for applicant/accused.
