1. I have heard Chief Public Prosecutor for the State, as well as, counsels for the accused on the point of charge, perused the charge-sheet, the statements recorded under Section 161 Cr. P. C. and other materials available on record.
2. Chief Public Prosecutor for the State has argued that from the material on record *prima facie* case is made out against the accused.
3. Counsels for the accused have argued that the accused has been falsely implicated in this case and from the material on record no *prima facie* case is made out against him.
4. At this stage, the accused and his counsels have conceded to the framing of charge.
5. In brief, the case of the Prosecution is that on 27.04.2023 at about 05.39 am at Yamuna Pushta, in front of HR Public School, Jogabai Extension, Jamia Nagar, New Delhi, the

accused committed robbery of purse containing Rs. 5,500/-, Aadhaar Card, Registration Certificate of car, mobile phones of Samsung Company having SIM No. 8448662467 and Vivo Company having SIMs of Vodafone No. 8750274917 and 8929274917 of **Complainant Akanshu Yadav** by forcefully entering into his Xcent Car bearing No. DL-1Z-A-0450 by using a deadly weapon i.e. country-made pistol.

6. Further, on 29.04.2023 the accused got effected recovery of mobile phone, Aadhaar Card, RC of Xcent Car bearing No. DL-1Z-A-0450, which he dishonestly received or retained knowing or having reason to believe the same to be the stolen property of the **Complainant Akanshu Yadav**.
7. Further, on 29.04.2023 the accused got effected recovery of one country-made pistol and live cartridge which the accused had retained at his house i.e. R-187, Gali No. 2, Joga Bai Extension, New Delhi.
8. **In my view, from the material on record, *prima facie* case under Sections 394/397/411 IPC read with Section 25 Arms Act is made out against the accused.** Charge is framed accordingly, to which the accused pleaded not guilty and claimed trial.
