CR is put up before the National Lok Adalat today. The claimant/s & the representative of the insurer-OP are physically present with their learned advocates. The conciliator is present too. This case is taken up for conciliation but the said parties submitted that they have already settled the matter amicably outside the Tribunal.

Perused CR along with the terms & conditions for the settlement enshrined in the joint compromise-petition filed today by the said parties. Heard them. They have orally supported the contents of the petition and I am satisfied that they filed the petition, out of free will, being conversant with the facts & circumstances of the case and the contents of the petition. Hence, I allow the petition. The claim is thus fully & finally settled for Rs. 70,000/- (Rupees Seventy Thousand only 1/-)

The insurer-OP shall remit the amount, including interest, to this Tribunal [vide. Para : 9(h) r/w Para : 9(e) of the Order of the Hon'ble Supreme Court in In Re: Compensation Amounts Deposited with MACT & Labour Courts (MANU/SC/0533/2025) and Para-VIII r/w Para-V of the Notification No.26 Dated 02.5.25 of the Hon'ble Gauhati High Court], by RTGS/NEFT only, within 30 days.

Towards verification as per the aforesaid Order &

Notification (which could not be done today due to time-constraint as a huge number of cases have been fixed in this Lok Adalat and also for the reason that the claimant-side is not ready with the necessary documents & particulars), I hereby require the claimant/s to submit **verified** (by the Sheristadar of this Office) **photocopy** of : **(1) updated Passbook** (first & last page at the least) of his/her/their Account/s maintained with any Govt./Nationalised Bank, **(2) Certificate/s of his/her/their Banker/s** incorporating the necessary details (including Name & Account-number of the Holder and IFS Code of the Bank/Branch) of the Accounts [which is the sole basis for verification vide. Para : 9(f) & Para-VI of the aforesaid Order & Notification respectively], **(3) copy/copies of a cancelled Bank Cheque/es** of the said Account/s if Check-facility is availed, **(4) reliable document/s** reflecting his/her/their recent e-mail i/d (if any) and **(5) any reliable Photo Identity Card** (Passport, Voters I-card, PAN Card, AADHAAR Card, Driving License etc.) of himself/herself/themselves. He/she/they shall also appear physically for verification-hearing.

Supply a copy each of this order to both sides within a week from today.
