O R D E R

1. The above named accused charged for offence punishable under Section 283 of the IPC.
2. I have framed particular of offence above and read over to him in his vernacular. He understood the same. He plead guilty. I verified his plea. Voluntariness of the plea can be gathered from pursis (Exh-02) filed by the accused. Moreover, I put a specific question to the accused that, whether he knows the consequences of his plead guilty, it may result in to punishment. The accused stickup with his plea therefore, I arrived at the conclusion that, the accused voluntarily pleaded guilty. I accepted his plea. I hold the accused guilty.
3. I heard the accused in person. The accused submitted that, he is ready to pay the amount which is going to impose on him. The punishment provided for Sec.283 of the IPC is up to fine amount of Rs. 200/- . The accused is ready to pay of Rs.200/-. Therefore, I am of the view that, Rs.200/- shall be imposed on the accused. Hence, I passed following order.

OPERATIVE ORDER

- 1 The accused Sheikh Hafij Sheikh Ismail, Age: 49 years, occ : Driver ,R/o Nandgaon Kh., Tq. Nandgaon Kh., Dist. Amravati is convicted for the offence punishable under Sec. 283 of the IPC vide. Section 252 of the Criminal Procedure Code.
- 2 The accused is sentenced to pay amount of Rs. 200/- in words Two hundred only in default payment of fine, he has to suffer S.I. Of 2 days.
