

Jagdish Singh vs. State

ORDER:-

1. Due to lock-down/curfew having been imposed in the state of Punjab, this anticipatory bail application filed on behalf of the above named applicant Jagdish Singh son of Nahar Singh has been presented through his above named counsle today before the undersigned being a duty Judge.
2. Heard at preliminary stage. Notice of the anticipatory bail application has been issued and given to the State through Ld. Additional PP deputed on duty for today. Let record of investigation and file be summoned from SHO/Investigation Officer/Duty Officer of Police Station Amloh for 24.4.2020. All other offences are bailable except the offence punishable under sections 452 IPC. Till then the above named applicant is hereby granted interim anticipatory bail with direction to him to surrender before the investigation officer/Duty Officer/SHO Police Station Amloh and join investigation and cooperate in every respect. In the event of his surrender before the investigation officer/duty Officer/SHO Police Station Amloh, he be released on interim bail after joining him in investigation. This interim bail is hereby granted for the above said offences only as those are stated in bail application till next date of hearing and subject to all those conditions as are stipulated under section 438(2) Cr.P.C., which shall remain binding upon the applicant till further orders.
3. Report regarding surrender and joining of investigation by the applicant be submitted on the next date as fixed above along with entire record of the investigation before the next Ld. Duty officer/Judge on the next date of hearing for further orders as per law facts and circumstances. It is also clarified that while joining the applicant in investigation all the mandatory norms and protocol social distancing and those of avoiding chorona covid-19 be followed strictly to avoid any apprehension of further spreading of the same.
