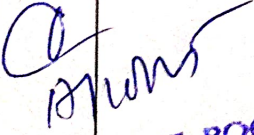

	17/10/2025	1. Seen the bail petition no: 1090 filed on behalf of the accused Shri Kishan Nath praying to allow him to go on bail. 2. The informant, who is the mother of the minor victim girl and also the victim are present and vide petition submitted that they have objection to the grant of bail. 3. The accused, Shri Shri Kishan Nath was arrested on 22/7/2025 in connection with this case and since then he is in continuous judicial custody. 4. Heard the parties. 5. The informant is the mother of the minor victim girl, and she had filed the ejahar on 22/7/2025 and alleged therein that on 21/7/2025 her minor daughter, who was aged about 13 years of age, went to buy medicine and then the accused touched her inappropriately on her breast area and also kissed her, hence this case. 6. The learned counsel for the bail petitioner had contended that there

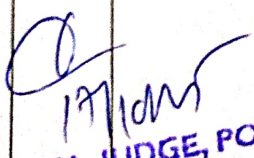

is no material on record to show that the accused had committed sexual assault; hence the accused may be allowed to go on bail. It is also submitted that the investigation in this case is already complete and there is no likelihood of early resumption of trial as the Ld. Special PP has already resigned and no new Prosecutor is appointed for trial of POCSO cases, as yet; hence the accused may be allowed to go on bail.

7. The Ld. Addl. PP has submitted that the prayer for bail may be rejected.

8. I have perused the case record, and it appears that the IO completed the investigation in this case and submitted chargesheet against the accused Shri Kishan Nath **under section 75 BNS BNS and Section 8 of the POCSO Act.**

9. It is seen from the perusal of record that the investigation in this case is already complete and there is less likelihood that the accused would abscond or that he would influence witnesses.

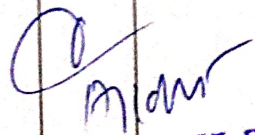

10. It is also to be noted herein that the Ld. Special PP for conducting POCSO cases had already resigned, and no Special PP is appointed till date for conducting the POCSO cases.
11. Considering the nature of offence and the length of detention and the fact that there is no likelihood of early resumption of trial in this case, the prayer for bail is allowed.
12. The prayer of the informant and the victim to reject the prayer for bail is rejected because no prima facie material could be placed by them to show as to why the bail ought not be allowed in this case.
13. The accused, **Shri Kishan Nath is allowed to go on bail of Rs.50,000/- with one surety of like amount** and the accused person is further directed to comply with the conditions laid under section 480(3) BNSS and directed that he shall not abscond; and not interfere with the investigation or threaten witnesses and would not try to influence witnesses.
