02-11-2022.

Suit is for a judgment and decree against the defendants, (a) to declare that 1st plaintiff's name in the SSLC Certificate of her daughter 2nd plaintiff shown as "PRAVEENA DSOUZA" is wrong and its should be "PRAVEENA DSA", (b) to grant consequential relief directing to the defendants to rectify the name of the 1st plaintiff in the SSLC Certificate of her daughter 2nd plaintiff as "PRAVEENA DSA" in the place of "PRAVEENA DSOUZA" in the register maintained for the year 2017, (c) to grant such other and further reliefs as the court deems fit under the circumstances of the case may be required.

The cause of action for the suit arose on and since 11-06-2022 date of issue of notice under Sec.80 of the Code of Civil Procedure to the defendants which is within the jurisdiction of this Court.

The value of the suit for the purpose of Court fee and jurisdiction is Rs.1,000/- and Court fee of Rs.25/- is paid for relief of declaration under Sec.24(d) of Karnataka Court Fee and Suit Valuation Act, 1958.

This suit coming on 27-01-2023 & 15-02-2023 for recording evidence and on 22-02-2023 for hearing arguments before me in the presence of Sri. Mithun Kumar, advocate for plaintiffs, Sri. C. Vijay Hegde, advocate for defendant No.1 and defendants No.2 to 5 being represented by D.G.P. and the matter having stood over till this day for consideration, this Court doth hereby Order and Decree as follows:-

- (i) that, the suit of the plaintiffs is hereby decreed,
- (ii) that, it is hereby declared that the name of the 1st plaintiff as 'Praveena DSA',

- (iii) that, the defendants shall correct and change the name of the 1st plaintiff as 'Praveena DSA' instead of 'Praveena Dsouza' in the SSLC certificate of 2nd plaintiff, after collecting fees.
