Name:- Nirmal Chakraborty, Aged – 48 years, S/O – Lt. Dulal Chakraborty, Present Posting– Kalamchoura PS, District – Sepahijala, Occupation – Govt. Employee.

Examination-in-chief:

On 12.06.2025 I was posted at Kalamchoura PS as Constable. On that day my duty was in second shift commencing from 02:00 pm to 10:00 pm. I accompanied Inspector Arup Debbarma and SI Shanti Bahu Tripura at Boxanagar Dakshin para where a person was detained by BSF. During the enquiry that person disclosed his name as Saddam Hossain. Member Firoj Miah was present. There was 8 bundles along with Saddam Hossain. First of all we were searched, then those bundles were found from the possession of Saddam Hossain. In 8 bundles there was 48 kg ganja having 6 kg in each bundle. I signed in seizure list as witness. Witness admitted his signature in seizure list, it is marked as **Exbt. 3/5**.

Saddam Hossain is present today in the Court. Witness identified

the accused person.

Cross-examination by Defence:

I gave statement in c/w this case. Whenever we go out for duty from PS the fact is recorded in GD book. In my statement I have not disclosed the GD number under which we went out from PS.

I have not stated to the IO that on 12.06.2025 from 02:00 pm to 10:00 pm I was on duty.

My pre search was not done in c/w this case.

In my statement I have not disclosed that I signed in seizure list.

It is not a fact that I signed in seizure list at PS being instructed by my senior officer.

It is not a fact that on 12.06.2025 I did not accompany Inspector Arup Debbarma and SI Shanti Bahu Tripura at Boxanagar Dakshin para.

It is not a fact that we did not find that a person was detained by BSF.

It is also not a fact that 8 bundles of ganja having 6 kg in each was not found from the possession of Saddam Hossain.

It is not a fact that member Firoj Miha was not present at the time of search and seizure.

It is not a fact that first time I saw Saddam Hossain at PS that is why he was identified by me in the court today.

It is not a fact that my evidence is not true.
