Mr. Harshvardhan, proxy counsel for accused Prakash, Arun and Sahil Gupta.

Accused Prakash and Arun absent.

Accused Sahil Gupta and Shiv Kumar in person.

- 1) The learned counsel for accused Arun submits that he is in custody at PS Ambedkar Nagar, however, he does not have any information regarding FIR under which accused Arun has been detained.
- 2) An application seeking exemption from personal appearance filed on behalf of accused Prakash citing suffering from viral fever. Heard. Allowed for today only subject to filing of medical record. He is directed to appear in person on the next date of hearing.
- 3) Summons stands served upon Inspector Ajab Singh and Inspector Neeraj Kumar.
- 4) Regardless, matter be kept back for summoned witnesses.

- 6) At this stage, Mr. Harshvardhan, proxy counsel for Mr. Anil Tomar, counsel for accused Prakash, Arun and Sahil Gupta submits that presently, accused Arun is detained at PS Ambedkar Nagar with regard to FIR No.513/2025 under section 304(2), 3(5) Bharatiya Nyaya Sanhita, 2023.
- 7) In view of the above submissions, PW Inspector Ajab Singh (Retd) is discharged unexamined. Diet money be paid.
- 8) Issue fresh summons to PW Inspector Ajab Singh (Retd) and MHC(M) with case property for next date of hearing.

- 9) Issue production warrants of accused Arun with regard to FIR No.513/2025 under section 304(2), 3(5) Bharatiya Nyaya Sanhita, 2023 for next date of hearing.
- 10) Copy of this order be transmitted to concerned IO/SHO PS Ambedkar Nagar for information and compliance.
- 11) Copy of this order be transmitted to Jail Superintendent for compliance.
- 12) Now to come up for PE on **23.12.2025**.
