Proxy Counsel for Revisionist submits that he will file fresh Vakalatnama on behalf of Revisionist in few days time period.

Written submissions of Respondent through Counsel were filed on 02.04.2026.

With the written submissions of Respondent / Counsel as a service of proof, a screenshot of a *whatsapp* communication has been placed on record depicting it being sent to some mobile number reflecting no name of recipient and the same cannot be taken as proof of service.

Copy of written submissions of Respondent given by Counsel for Respondent to proxy Counsel of Revisionist.

Revisionist / Counsel did not file any written submissions despite opportunities granted in terms of previous orders.

15 days time period was granted on 19.01.2026 for filing of brief written submissions by the parties / Counsel.

Proxy Counsel for the revisionist submits that only yesterday night around 10:00 p.m. e-filing of written submissions was done.

Reader submits that on CIS portal, there is no e-filing of written submissions of revisionist / Counsel.

Bare perusal of the revision petition reveals that as per Memo of Parties, five revisionists are arraigned therein namely (1) Jai Prakash Educational Trust Society ; (2) Hari Om Agarwal ; (3) Anurag Agarwal ; (4) Vishal Agarwal and (5) Sangeeta Agarwal ; whereas the petition is only signed by Revisionist no.3 Anurag Agarwal supported by affidavit of Revisionist no.3 Anurag Agarwal and none else amongst the arraigned Revisionists.

How can Revisionists no.1, 2, 4 and 5 maintain the present revision petition ; having not signed it nor supported it with any affidavit ?

In this fact of matter, it is made clear that there is no operation of stay on the impugned order as previous orders have not been complied by the Revisionists.

Copy of this order be sent to Ld. Trial Court for information and appropriate action.

Written submissions on aforesaid facet be filed by the Revisionists / Counsel, not exceeding three pages with relied
