He submits that he does not have any counsel at present and seeks a counsel at the expense of the State. Accordingly, Sh. Praveen Yadav, LAC is assigned the case of Shamim @ Lala, so as to represent him before this court.

Part submissions heard on the point of charge. There are certain queries, which require answer from the IO viz. any witness/evidence related to incident taken place at the shop of victim Janardan, commonality of the mob in respect of all the incidents being prosecuted in the present case etc.

There is no information in respect of any steps, if being taken after arrest of accused Shamim @ Lala, who was declared PO in this case. On next date, SHO as well as IO/SI Naveen, both shall appear to inform the court about the steps taken qua Shamim @ Lala and to respond to the queries related to the point of charge as mentioned here-in-above. **Court notice be sent to both these officials with a copy of this order.**
