Hisar and by sale of Hypothecated crops and other properties and assets of the defendant. On the basis of oral and documentary evidence of all kind.

pay the outstanding amount of Rs.7,92,804/- along with interest pendentelite and future at the rate of 11.65% per annum from 04.08.2022 till realization of decretal amount to the plaintiff, within 30 days from the date of order, failing which, the plaintiff bank shall be at liberty to recover the aforesaid amount by sale of mortgaged and hypothecated property.
