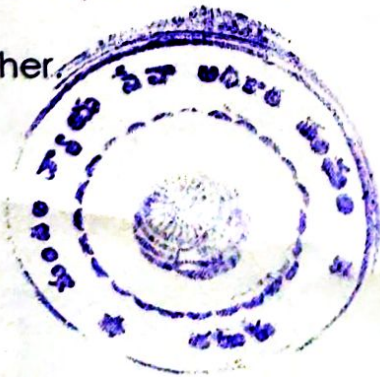

AWARD

- 1) The Respondents paid an amount of Rs. 6,50,000/- (Rupees Six Lakhs Fifty Thousand only) by way of DD. Bearing No. 000090, HDFC Bank Tingare Nagar Branch the same has handed over to the Petitioner by name Maridu Kedhar Tirupama Devi, again the accused has paid an amount of Rs. 6,50,000/- (Rupees Six Lakhs Fifty Thousand only) by way of DD Bearing No.001648 HDFC Bank Vuyyuru Branch total (Rs. 13,00,000/- (Rupees Thirteen Lakhs Only) paid by the Respondents towards past, present, future maintenance and permanent alimony of the Petitioner and the same is received by the Petitioner.
- 2) The Petitioner had relinquished her right of past, present, future maintenance and permanent alimony against the Respondents.
- 3) The Petitioner agreed to co-operate with the Respondents in getting divorce in the Petition filed by him at Senior Civil Judge Court Tanuku.
- 4) Both the parties agreed not to file any civil or criminal cases against each other in future.
- 5) Both the parties have no claims or counter claims against each other.

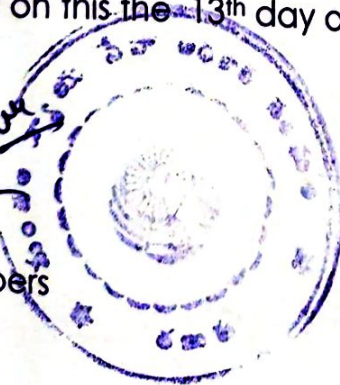
