PW7 Anjali Pahwa is present for her cross-examination.
But the counsel for the accused submit that they would like to cross-examine her with PW5 Sh. Prem Kumar Batra and Sh. Naresh Kumar Batra. Perusal of file shows that chief of PW5 Sh. Prem Kumar Batra is deferred for want of case property and chief of PW Sh. Naresh Kumar Batra has not been recorded.

PW5 Sh. Prem Kumar Batra is present. But the case property is not produced. It is submitted by SI Ashok Kumar that the case property is lying in Malkhana of PS Ghari Pukhta, District Shamli, UP and they will produce the case property on the next date on summons. Heard. Issue summons to MHC(M) PS Ghari Pukhta, District Shamli, UP with the direction to produce the case property on the next date. The summons will be served through SSP and SHO concerned. Two copies be given to IO and one set be given to SHO

concerned. It is made clear that if order is not abided then the same will attract, show cause notice. Present SHO will ensure the presence of the case property on the next date.

The case is lingering on at the instance of accused person because it is not possible to conduct the cross-examination of three witnesses simultaneously. Still, they are insisting upon the same and the witness PW7 Ms. Anjali Pahawa being discharged for the same. PW7 Ms. Anjali Pahwa be summoned only after the completion of chief examination of PW Sh. Naresh Kumar Batra and PW5 Sh. Prem Kumar Batra. **No summons be sent to her.**

An application for filing status report from jail supervision filed on behalf of the accused Rohit Gupta by legal aid counsel Sh. Manish Kumar. Let the report be called from Jail Superintendent for 17.08.2018 and he be also called for the said date to appear in person.

An application for release of original RC of vehicle bearing No. DL 8CS 6444 filed by applicant/surety Tarun Nagpal. At request, the same be listed for next date.

To come for remaining prosecution evidence on **20.09.2018**. PW5 Sh. Prem Kumar Batra and Sh. Naresh Kumar Batra be summoned for through IO/SHO concerned for said date.
